PV RULES and REGULATIONS: Pit vehicle use is a privilege and not a right. I acknowledge and agree to the following:

1. PVs are mopeds, scooters, pit bikes, golf carts and mules only. No ATVs, Pilots or 6-wheel Gators for Bike Week.
2. **Operators must be at least 18 years of age.**
2. PV may not be operated in a reckless, careless, or dangerous manner, and may not be operated by anyone under the influence of alcohol.
3. PV use limited between the hours of: **7 am – 10:30 pm.**
4. PV speed limit: **5 mph.**
5. Helmets must be worn for 2-wheeled PV.
6. Passengers must be seated.
7. PV may only cross the county road at the designated cart crossing across from the swimming pool.
8. Pit vehicles are **NOT** allowed in the following areas: Motocross Track or inside the track fence, trails, woods, county roads or Western Town.
9. Violation of any of the above rules is grounds for penalty, including but not limited to: confiscation of PV, disqualification of racer, and/or removal from the facility.
