In consideration of being granted an opportunity to race at Loretta Lynn's Ranch, Hurricane Mills, Tennessee, produced by MX Sports, Inc. and intending to be legally bound hereby, I, for myself, my heirs, personal representatives and assigns, HEREBY RELEASE, DISCHARGE AND AGREE TO HOLD HARMLESS AND INDEMNIFY MX Sports, Inc., the American Motorcyclist Association and their district organizations, Loretta Lynn's Ranch, Inc., Loretta Lynn Enterprises, Inc., and Loretta Lynn individually (Loretta Lynn Entities), the owners, sponsors, and manufacturers of all racing equipment upon the premises, and the officers, directors, officials, representatives, agents and employees of all of them, OF AND FROM ALL LIABILITY, LOSS, CLAIMS, DEMANDS AND POSSIBLE CAUSES OF ACTION that may otherwise accrue FROM ANY LOSS, DAMAGE OR INJURY (INCLUDING DEATH) TO MY PERSON OR PROPERTY, in any way resulting from, or arising in connection with, or relating to, any scheduled event, and whether arising while engaging in competition or in practice or preparation therefore, or while upon, entering or departing from said premises, from any cause whatsoever including without limitation the failure of anyone to enforce rules and regulations, failure to make inspections, or the negligence of other persons.
